An existing Not for profit Company had intended to change its name and accordingly filed Form INC-1 by applying following name vide SRN G04079885

## "INTERNATIONAL SAFETY AND SECURITY PROFESSIONALS' ASSOCIATION"

Within few hours such company got communication from MCA rejecting the name on the reason reproduced below

Proposed names includes a name of registered trade mark. Hence, it is not considerable in view of provisions of rule 8(2) (a) (ii) of Companies (Incorporation) Rules, 2014. The details of trade mark is as under: 1238342 99 INTERNATIONAL TRUCK INTELLECTUAL PROPERTY COMPANY, LLC. 2701 NAVISTAR DRIVE, LISLE, IL 60532, UNITED STATES OF AMERICA Registered. Please furnish fresh names to avoid rejection

Reason cited for rejection is, out of six words of proposed name one word is already registered trade mark at USA. It implies henceforth no company can apply any name with the word INTERNATIONAL.

We have been reported similar instances previously by number of Companies and this practice of MCA officials is creating obstacles in getting company formed. However later on name is approved, How? Only MCA official knows better?. These kinds of obstacles are encouraging gratification with Government Officials.

Earlier vide our letter dated 30.12.2015, we had drawn your kind attention, copy of letter is attached. Availability of name to register a new company has become a nightmare. Unfortunately a significant barrier to Ease of Doing Business could not be removed.
